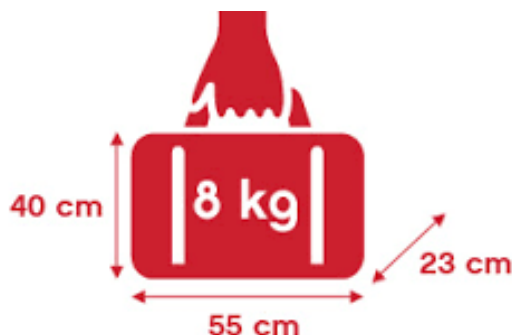
**An item of baggage must not exceed 158 cm in size (width + height + depth).**

Any items of baggage that are bigger or heavier will be transported as excess baggage. If the number of items of free baggage is exceeded, there will be a charge for every additional item of baggage. Our code share partner LX does not accept any items of baggage weighing more than 32 kg.

**Hand Baggage**

1 x max.8 kg Bag, Circumference max. 55 x 40 x 23 cm

Hand baggage that is too big or too heavy will be taken at the gate and carried as checked baggage, for which there is a charge.

### **Check-in at the desk (Check-in 1 or 3)**

Opening times of check-in desks at the day of departure vary according to the airport and the flight duration but it is in general 2 - 3 hours before the flight (Swiss counters).
